#### Location:

The property is located within the established Castlepark Industrial Estate, Castle Street, within the popular commuter town of Ellon. Ellon lies approximately 26 kilometres (16 miles) North of Aberdeen City Centre and 27 kilometres (17 miles) Southwest of Peterhead on the A.90 trunk road. Extract plans are provided showing the approximate location of the subjects.

# **Description:**

The property comprises a workshop unit with secure compound located within a terraced industrial development. The unit is of steel portal frame construction with concrete floor and concrete block walls. The roof is pitched with profile sheet cladding incorporating translucent panels for natural lighting. Vehicular access is provided by a roller shutter door on the front elevation. A separate pedestrian door provides personnel access. Internally, the unit provides workshop space together with a single toilet. Artificial lighting is provided by suspended fluorescent fitments. A sink is located within the workshop. A secure compound is available to the side/rear of the unit. Common car parking is provided to the front of the property.


